







STATEMENT IN PRINCIPLE ON MENTAL HEALTH and Non-Violent CRISIS INTERVENTION TRAINING FOR LAW ENFORCEMENT PERSONNEL

Recognizing that:

- police officers and other first responders are often the first people to contact individuals who are experiencing a mental health crisis and that police are often called upon to convey individuals to appropriate facilities for psychiatric assessment under the *Mental Health Act*;
- appropriate training of first responders in mental health issues and non-violent crisis intervention will benefit the well-being and safety of everyone;
- some police services already provide significant mental health and non-violent crisis intervention training for their officers;
- currently in British Columbia there are no province wide standards for the uniform provision of mental health and non-violent crisis intervention training for law enforcement personnel, nor is adequate funding provided to police agencies specifically for this training;
- several juries at Coroners' Inquests have recommended training for police officers in more
 effective and humane ways of interacting with people with mental illnesses, especially when in
 crisisⁱ;
- individuals with a mental illness or substance misuse problems come from many different cultural backgrounds, including First Nations communities; and
- law enforcement personnel would benefit from a standardized culturally competent mental health and non-violent crisis intervention training based on best practice;

The following organizations call upon the British Columbia Ministry of Public Safety and the Solicitor General to require and to provide funding for the immediate development of standardized mental health and non-violent crisis intervention training based on a best practices model to be implemented in all police services and other first responders operating in the province of British Columbia:
