We want to remove the stigma of mental illness at work and empower those living with it to achieve their career and education goals. The LGM Continuous Learning Bursary launched in 2014 in order to help empower those with mental health and substance use issues who are passionate about continuous learning.

One bursary worth \$800 will be awarded to an individual living in British Columbia with a mental illness or substance use problem. The bursary is administered by the Canadian Mental Health Association (CMHA), BC Division.

WHO CAN APPLY?

Successful applicants for the educational bursary must meet the eligibility criteria outlined below:

- Experience of a mental illness or substance use problem
- Accessing therapeutic support/mental health services
- An identified job goal
- A demonstrated education goal for financial assistance
- Will enroll at the fully accredited Athabasca University via distance learning by December 1, 2016
- At least 19 years of age and a resident of British Columbia

Members of a review panel evaluate applications and recommend who should be selected for the bursary.
