As Victoria's city council member, one of my main objectives would be to ensure that the Community Wellness and Peer-Informed Task Force would have an Indigenous representative that would help provide insight and guidance for how to approach these systemic barriers. Additionally, I would continue pursuing Truth and Reconciliation efforts in the city because, according to the PiT report, 62% of Indigenous people are closely related to, or are former residential school survivors. Lastly, I would continue to implement Indigenous-led services and programs for Indigenous women to help address the 44% of Indigenous people who are homeless being women. We need culturally sensitive programs especially relating to and understanding the barriers and discrimination indigenous peoples face.

General comments/thoughts about Mental Health and Well-being in Victoria

Hello everyone, my name is Anna King and I'm a candidate for City Council. When I think of Mental Health, I think about my own journey. When pregnant with both my children, I had severe antenatal depression, which is depression during pregnancy rather than the more common, postpartum depression. It took me on a journey of trying Cognitive Behavioural Therapy, CBT and I appreciated the tools it gave me to manage in time when the pandemic, pregnancy, and home renovations all collided.

At a municipal level, Mental Wellness needs to be a lens we apply to all decision: the provision of housing, greenspace, arts and culture, recreation, childcare, and community centre programming. A sense of belonging and comfort improves mental health. So, urban design has an important impact on wellness. When we do our best to be inclusive, we help folks feel seen and heard.

Having worked in the Downtown Eastside for 3 years with those struggling with mental health, poverty, and addiction, this issue is close to my heart. As for the mental health crisis as it relates to those on the streets, we need a health-first approach rather than simply adding by-laws and enforcement. The Peer Assistance Response Team rolling out this fall is a good first step towards helping those who need it most. We need compassionate social workers and psychiatric nurses to provide wrap-around support in addition to housing.

Overall, we need to remove stigma around mental health conditions. I whole-heartedly support campaigns like Face to Face with Stigma that uses storytelling as advocacy. Moreover, we need to do what we can in regards to suicide prevention such as equipping employers, health care workers, teachers, and parents with the knowledge to detect early signs of depression and suicide risks. The city can do this by continuing to support the Stigma Free Society, CMHA, and other charities doing this work through grants to provide services in the community.
